- ◆ 30 minute class = \$25.00
- ◆ 45 minute class = \$30.00
- ◆ 1 hour class = \$35.00
- ◆ 1.5 Hour class = \$50.00

*\*(any additional 15 minute increment will be an additional \$10.00 to the hourly rate)*

- ◆ 2 hour class = \$65.00
- ◆ 2.5 hour class = \$80.00
- ◆ 3 hours of class = \$95.00
- ◆ 3.5 hours of class = \$110.00
- ◆ 4 hours of class = \$125.000 (unlimited)

*\*(These hourly rates are per dancer pricing)*

**UNLIMITED CLASSES = \$125.00 per month per student (not eligible for additional discounts)**

- \* Competition fees are additional and separate
- \* Pay for a full year at registration time and receive a %10 discount. Discount is for monthly tuition only.
- \* \$5.00 per month discount for siblings unless paying for a full year and receive a %10 discount

Yearly discounts is for the months of September through May. Dependent on the recital date there may be a billing for the month of June. December tuition may be half price based on abbreviated schedule due to Christmas.
